

**Village of Bonney  
City Council Regular Meeting Minutes  
January 16, 2012**

Minutes of Regular City Council Meeting of the Village of Bonney held at the Village of Bonney City Hall located at 19025 FM 521, Bonney, Texas 77583. The meeting was called to order by Mayor Raymond Cantu at 7:00 P.M.

**Item 1) Regular Meeting Roll Call:**

**Item 4) Matters relating to Certificate of Deposit Maturity Notice:**

Mayor Cantu announced Village of Bonney Certificate of Deposit would be maturing in February and suggested a withdrawal be made so payment for 2007 road repairs could be made to Brazoria County. He stated the original invoice was \$5,709.18 and the current balance is \$4,709.18. Alderwoman Bevelria Doyle recommended \$5,000.00 be withdrawn from the C.D. at the 2012 maturity date. Motion was made by Alderman Manuel Cantu to approve the \$5,000.00 withdrawal of funds from Village of Bonney Certificate of Deposit when it reaches February maturity date. Motion was seconded by Alderwoman Jennifer Winans.

There were no visitors. Alderwoman Jennifer Winans reported a tornado had been reported touching down at China Grove.




