

**Village of Bonney  
City Council Regular Meeting Minutes  
November 21, 2011**

Minutes of Regular City Council Meeting of the Village of Bonney held at the Village of Bonney City Hall located at 19025 FM 521, Bonney, Texas 77583. The meeting was called to order by Mayor Raymond Cantu at 7:00 P.M.

**Item 1) Regular Meeting Roll Call:**

There was a quorum with the following members present: Alderman Tony Gonzalez, Alderwoman Bevelria Doyle, Alderman Manuel Cantu and Alderwoman Jennifer Winans. Alderwoman Terri Velasquez was absent; Mayor Raymond Cantu presided.

Mayor Cantu announced Village of Bonney had received and engagement letter from Karla Hoffmann, CPA, regarding preparation of Village of Bonney 2010-11 fiscal year audit and recommended the engagement letter be signed and returned to her. All Aldermen and Alderwomen were in agreement Village of Bonney would execute and return the engagement letter to Karla Hoffmann, CPA for preparation of 12010-11 fiscal year audit.

**Item 5) Matters relating to Rental Agreements**

Mayor Cantu reported that when the Community Center was rented on Saturdays and there was another function booked for the next day they sometimes had difficulty getting the Community Center cleaned in time for the Sunday function. After a brief discussion it was determined the Community Center would be closed to the public for rental on Sundays, but that the Pavilion, smoker and grill would still be available for Sunday rentals.

**Item 6) Matters relating to CDBG Public Funds Projects:**

Mayor Cantu reported that CDBG grants had been changed until 2014 and that the amount of grant money to be awarded would be increased to approximately \$130,000.

There were no visitors or public comments.




