

**Village of Bonney  
City Council Regular Meeting Minutes  
March 19, 2012**

Minutes of Regular City Council Meeting of the Village of Bonney held at the Village of Bonney City Hall located at 19025 FM 521, Bonney, Texas 77583. The meeting was called to order by Mayor Raymond Cantu at 7:00 P.M.

**Item 1) Regular Meeting Roll Call:**

There was a quorum with the following members present: Alderwoman Bevelria Doyle, Alderman Manuel Cantu, Alderwoman Jennifer Winans and Alderwoman Terri Velasquez; Mayor Raymond Cantu presided. Alderman Tony Gonzalez was absent.

**Item 2) Matters relating to 2010-11 Audit by Karla Hoffmann, CPA:**

Ms. Hoffmann was unable to attend; Mayor Cantu tabled this item until April Council Meeting.

**Item 3) Matters relating to Sealed Bids requested/received for VOB Phase IV Construction Project:**

Mayor Cantu opened sealed bids received for VOB Phase IV Construction Project with the following bids received:

**Item 4) Matters relating to Sealed Bids requested/received for VOB Phase V Construction Project:**

Mayor Cantu opened sealed bids received for VOB Phase V Construction Project with the following bids received:

- Tri-Point Construction                        No Bid

Mayor Cantu announced Ricky Jones Construction was low bidder on both VOB projects and that bids would be reviewed in the next thirty days and letters would be sent to bidders with decision.

**Item 6) Matters relating to Treasury Report:**

The Treasury Report was presented and bank balances were reported as follows:

Mayor Cantu reported checking account balance was higher than normal due to receiving claim money from TML for accident reported in February and transfer of funds from Certificate of Deposit to pay Brazoria County for 2007 road repairs.

**Item 7) Matters relating to Proposed Ordinance #2-2012 Canceling Annual General Election:**

Mayor Raymond Cantu announced Candidate Applications had been received from Manuel Cantu, Jr. for Alderman Position 3, Jennifer Winans for Alderman Position 4 and Terri Velasquez for Alderman Position 5. Mayor then presented proposed Ordinance 2-2012, Canceling Village of Bonney 2012 Annual General Election as there had been no opposing candidates. After review of the Ordinance, Alderwoman Bevelria Doyle made motion that the 2012 Annual General Election be cancelled and Ordinance 2-2012 be approved and executed. Alderman Manuel Cantu seconded the motion.

Alderwoman Jennifer Winans made motion to execute Village of Bonney 2012 Investment Policy and motion was seconded by Alderwoman Terri Velasquez.

**Item 9) Matters relating to Aerial Spraying by Brazoria County Mosquito Control:**

Mayor Raymond Cantu reported that Brazoria County was requesting permission to conduct aerial spraying of mosquitoes during 2012.

Motion was made by Alderman Manuel Cantu to grant permission to Brazoria County to conduct aerial spraying of mosquitoes over Village of Bonney throughout 2012 and seconded by Alderwoman Bevelria Doyle.

Mayor Cantu informed Aldermen and Alderwomen Brazoria County CDGB had requested that we participate again this year in the "Fair Housing Month" by executing a Proclamation declaring April 2012 as "Fair Housing Month" and posting in the newspaper and on our City Hall bulletin board.

Motion was made by Alderwoman Jennifer Winans to adopt and post proposed April 2011 "Fair Housing Month" Proclamation. Motion was seconded by Alderwoman Terri Velasquez.

**Item 11) Public Comments:**

Mayor Cantu welcomed Mr. and Mrs. Ricky Jones and Arthur Velasquez and thanked them for attending. Mr. Velasquez announced that Brazoria County was conducting an Adult Probation city-wide clean up and if Bonney residents would put trash (including tires) in front of their property on the Right of Way the city would pick up these items as part of Community Service. He reported that the workers would be unable to go on private/personal property and items would need to be placed on the Right of Way. He said Bonney would need to contact Charles McMurray with Brazoria County Adult Probation to get dates they would be picking up in the

Bonney area. Mr. Velasquez also presented Village of Bonney with a new redistricting map from Brazoria County.
