

**Village of Bonney

Minutes of Regular City Council Meeting of the Village of Bonney held at the Village of Bonney City Hall located at 19025 FM 521, Bonney, Texas 77583. The meeting was called to order by Mayor Raymond Cantu at 7:00 P.M.

On June 13, 2012, a FedEx truck ran into and damaged the power lines connected to the Community Center. TML is looking at the costs to fix the damages. An insurance check will be given, but it will temporary fall on our expense account.
