

**Village of Bonney

Alderwoman Jennifer Winans made motion to accept the modifications deleting the walking trail project and completing the extension building to Community Center as presented and motion was seconded by Alderman Tony Gonzalez.

Mayor Cantu reported Community Center rentals were doing well and rental income received was over the annual amount budgeted for 2010-11.


Item 8) Public Comments:


